••• Supportive Govt. Initiatives: Business-Friendly Ecosystem Continuously Evolving!

- Window for migration of industries from 'Fiscal Incentives for Industrial Promotion (Revised) – 2013' to 'Industrial & Business Development Policy 2017' has been re-opened till 31st Dec 2020. Industries that have not availed/availed partial incentives from 2013 policy & have not commenced production can now avail benefits under the 2017 policy.
- With promulgation of the Factories (Punjab Amendment)
 Ordinance, 2020, the total number of overtime hours in any quarter have been increased from 75 to 115.
- To promote higher education, Punjab Govt. has reduced the requirement of a specific covered space from 50,000 sq mt to 30,000 sq mt for private universities (engineering/ medical/ arts & science). For universities with any other domains, it has been reduced from 20,000 sq mt to 15,000 sq mt.
- UPCOMING: Punjab Housing and Urban Development Dept. will be supplying additional 20 mn gallons daily water from Kajauli waterworks to Mohali industrial area to reduce pressure on ground water.

To facilitate sustainable industrial growth & provide world-class common infrastructure, Punjab Government has announced various Industrial Parks across the State



Status:

 Land in possession of PUDA for park development.

Ecosystem:

- Most industrialized district in Punjab accounting for 36% of industrial power sale
- Presence of Multi Modal Logistics Parks (Adani, Sharaf Group etc.)
- Ludhiana is the largest textile hub in North India.



Notification for Online single window clearance system for film shooting permissions released

Punjab's Rich culture & heritage make it an ideal destination for film Shooting. Patiala, Amritsar, Mohali and Ropar are popular shooting destinations. The globally renowned culture, cuisine and songs of Punjab are widely used in today's movies. Building on the ecosystem, the Government of Punjab has released a notification for online single window clearence system for film shooting permissions. Invest Punjab is now the nodal department for all film shooting clearances. The clearances can now be obtained through Invest Punjab Business First Portal within 15 days. The status of application is visible to the applicant, making the system transparent, accountable and user-friendly. Invest Punjab looks forward to welcome film shooting crews and their feedback to make the system more robust.



Standing Together: Punjab Government & Tourism Industry

September 27 is observed as World Tourism Day. However, this year, the onset of Covid-19 cast a shadow on the celebrations. Government of Punjab is cognizant of the fact that Tourism and Hospitality sectors are amongst the most severely affected sectors post the pandemic and the Government is ready to stand shoulder to shoulder with them. In order to support the revival of these industries, Chief Minister of Punjab took the decision to waive off annual liquor license fee for marriage palaces, bars, hotels and restaurants for the year 2020-21, proportionately for the period Apr to Sep 2020. Besides, the quarterly assessed fee for the first two quarters of the year (Apr – Jun & Jul – Sep 2020) has also been waived off.

Punjab Tourism Department will provide free training and upskilling of the youth interested in careers in tourism and hospitality sectors post Covid-19. More than 2000 students will be trained under the umbrella scheme of 'Hunar Se Rozgar Tak' (From Skill to Employment). Moreover, the Government will also be assisting these students in finding placements.
